

**READ THIS BEFORE SIGNING**  
**Release and Grant of Rights**

IN CONSIDERATION of my participation in and/or attendance at this audition (the "Audition"):

- (1) if I am participating in the Audition, I hereby (a) acknowledge that the Audition may be physically demanding and that there may be risks directly or indirectly related to my participation in the Audition including, but not limited to, the possibility of physical injury, (b) expressly assume all risks relating to my participation in the Audition, (c) acknowledge that I have no pre-existing medical condition that would prevent me from participating in the Audition, (d) release, waive and discharge MSG Sports & Entertainment Holdings, LLC, MSG Entertainment Holdings, LLC, Radio City Productions LLC, The Madison Square Garden Company, and their affiliates and their respective owners, partners, affiliates, subsidiaries, designees, licensees, successors and assigns (collectively referred to herein as "MSG"), and their respective officers, directors, independent contractors, employees, and agents, (collectively, the "Releasees") from any and all liability, loss or damage that I, my assignees, heirs, guardians, next-of-kin and legal representatives may suffer or incur, now or in the future, as a result of my participation in the Audition, including, without limitation, death, personal injury or property damage, regardless of whether it was caused in whole or in part by my negligence or the negligence of any Releasee and (e) covenant not to sue nor to assert any claim against any Releasee as a result of my participation in the Audition, and further acknowledge that the release, waiver and covenant not to sue contained in this Section (1) is intended to be as broad and inclusive as is possible;
- (2) I hereby irrevocably grant to MSG the broadest possible rights to use my participation in and/or attendance at (or outside of) the Audition and my name, likeness, photograph, image, voice and biographical information in connection with the Audition, in any and all manner, and in any and all media now known or hereafter developed, throughout the universe, in perpetuity for any and all purposes, without restriction, limitation or condition, without any compensation to me, consent from me or any limitation whatsoever (the "Use") and hereby release the Releasees from any and all claims arising out of or in connection with my participation in and/or attendance at (or outside of) the Audition and/or the Use, including, without limitation, any claims for libel, slander or invasion of privacy; and
- (3) this Release and Grant of Rights represents the entire agreement between MSG and me with respect to the subject matter hereof and supersedes all prior agreements between us with respect to such subject matter, whether written or oral. This Release and Grant of Rights may not be altered or amended except in writing signed by both parties.
- (4) By auditioning, I agree that MSG may send me emails at the address provided from time to time on behalf of MSG, its affiliates and promotional partners regarding the Rockettes and other events, promotions, products, activities, and venues, which I may opt-out of receiving in accordance with the instructions provided in any such email. Any such emails will be sent in accordance with MSG's online privacy policy (as available online and as the same may updated or amended from time to time).
